

### Nurse Manager/Nurse Director/Nurse Executive Fellowship: Application Eligibility

## Who Should Apply?

#### **Nurse Manager Fellowship**

Applicants should have a minimum of one year experience as a nurse manager. Job title is not the determining factor, but rather the role and responsibilities of the applicant's position as detailed in a current job description.

#### **Nurse Director Fellowship**

Applicants should have a minimum of one year experience at the director level. Job title is not the determining factor, but rather the role and responsibilities of the applicant's position as detailed in a current job description.

#### **Nurse Executive Fellowship**

Novice senior nurse executives with 0 to three years of experience in an executive role, including CNO, VP of Patient Services, System Director and COO.

This essay should provide insight into who the applicant is. The essay is not intended to be a narrative of the applicant's career journey, but a personal story detailing those experiences that have impacted the applicant's professional practice and defined who the applicant is as a leader.

#### **Organizational Chart (upload Word or PDF file)**

Applicants are required to submit an organization chart of their team showing their position in relationship to their supervisor, peers, and direct reports.

#### Statement of Support (upload completed PDF)

All Fellowship applicants are required to submit a statement of support from the sponsoring organization's Chief Nurse Executive (or equivalent) for NMF and NDF applicants or from the sponsoring organization's system CNE, CEO or COO (or equivalent) for NEF applicants. The Letter of Support Form can be found on page three of this file.

#### Capstone Project Proposal (limit one page – upload Word or PDF file) \*FOR NURSE MANAGER AND NURSE DIRECTOR APPLICANTS ONLY

The capstone project offers professional growth and provides a vehicle for the applicant to apply new learning and experience in the workplace. It is intended to benefit the sponsoring organization, which may be accomplished in various ways, e.g., through process improvement, improved resource management, program/service/business line development, et al. The project should provide a measurable financial gain for the organization. Additionally, the project should further develop and enhance the applicant's leadership competencies.

The proposed project must be a new project and not a project that is already in progress. A project that is a component of an academic course (required for degree completion) is acceptable. The project must be initiated in the Fellowship year, and it must meet all defined parameters. It is understood that every proposal is a work in progress and the focus and scope may change during the Fellowship year. This is taken into consideration when evaluating each proposal.

Your proposal should address the following:

- Project title
- Background and statement of the project objective
- Brief description of the project, tactical actions, and expected outcomes
- How outcomes will be measured
- How return-on-investment (ROI) will be measured
