

Financial Aid Application Guidelines – Finance and Business Skills for Nurse Managers

Background:

Financial Aid Package Details:

Funds available up to \$600 to be used for program tuition.

Eligibility Criteria:

- Applicant has support of leadership in their own organization to release time to attend all program sessions.
- May not be Sitting Board Members of AHA, AONL, or AONL Foundation.
- Priority will be given to small, rural, critical access, or other small non-profit, government or public health care organizations along the care continuum.

Evaluation:

Applications will be evaluated by committee. The application package will consist of:

- Biographical information for the applicant
- Complete the application with information relevant to Financial Aid award consideration

Requirements and Expectations of AONL Foundation Financial Aid Recipients:

- Provide a written report on the individual's experience of the program and the personal/professional/organizational impact of the program within 30 days of program completion.
- Allow the Foundation to use information in the report in promotional materials.
- Attend Foundation events as schedules allow.
